## NATIONAL IHL COMMITTEE, NEPAL

- Formed on 26 February 2007 vide Executive Order
- 11-member National Committee on IHL, chaired by Law Minister
- Representatives from Ministries of Law, Defense, Home, Foreign Affairs, Health, Education, Tourism, and Office of Prime Minister
- Representation at secretary or joint secretary level
- Joint Secretary at International Treaty Division as member secretary
- Secretariat in Law Ministry

## **Rule of Procedures**

- Expert or specialist may be invited
- Representative of other institutions may be invited
- Meetings to be held at least three times a year
- Power to form sub-committees

#### **Functions**

- Draft necessary laws
- Review existing laws for implementation of Conventions
- Make recommendation for joining other treaties as appropriate and taking measures for their implementation
- Ensure the fulfilment of Nepali's international obligations under IHL by assisting and encouraging the government agencies to develop policy on IHL
- Encourage international respect for and implementation of IHL
- Carry out all other activities for the implementation the Conventions on IHL
- Carry out other requisite acts including promotional acts

#### **Performance of National Committee**

Series of pre-consultation meetings at the stage of formation of National Committee (Separately and collectively):

- Government Ministries
- Nepal Army
- Other security agencies
- Nepal Red Cross Society
- Civil society members
- Technical support from ICRC
